I. Purpose

The Williamsburg Classical Academy Inc (WCA) community provides an opportunity for families to enhance their homeschool journey through classes, field trips, workshops, camps, clubs, activities, prom, dances, graduation, and more. WCA meets from 8:30 a.m. to 3:30 p.m., Tuesdays and Thursdays. We offer a variety of academic subjects, including art, history, math, languages, literature, science, and electives. These courses are listed on our website. WCA is not a school and therefore does not function as a school with a principal, support staff, janitors, etc. All families must comply with the required laws for homeschooling in their state/county.

WCA offers the following benefits:

- For our students, the variety of our academic courses enhances their home education curriculum. Students gain valuable experience in a group-learning environment involving responsibility to fellow students and to their instructors, and they enjoy this weekly connection and fellowship with homeschooled peers.
- For parents, our courses offer the level of academic instruction we desire for our own students and provide parents an alternative to planning curriculum and evaluating progress. In addition, the cooperative nature of our organization serves as a source of encouragement and fellowship for the entire family.

Everyone is enriched by the organization: the student, the home educators, the family, the instructors, parent and student community.

*WCA does not discriminate on the basis of race, color, religion, national, or ethnic origin in the administration of its admissions policies, educational policies, and programs.

II. Statement of Beliefs

WCA is a community of diverse homeschooling families. We strive to teach our students proper respect of elders, peers, and self. We exist to assist homeschooling families, not to teach specific doctrinal beliefs.

Students and their families are expected to conduct themselves in a manner which shows respect to the organization which provides us with a facility. As our current home is in a Christian church, students and their families, are expected to show proper respect for the beliefs of our host. Language, dress, and behaviors should always conform to the expectations of the community.

Instructors, students, and family members should show kindness and integrity in their dealings in the classroom, the common areas, and the community at large. Members of the community with religious beliefs that differ from yours should always be given proper respect. If you have questions regarding specific religious content in a particular class, please consult with the individual instructor.

III. Admissions Policies

Register with WCA by visiting our website: williamsburgclassicalacademy.org

A. Fees:

- Non-refundable Registration Membership Fee: \$165 per current family/ \$200 for Returning or New Families for class registration.
- Class Tuition: varies by class
- Material/Supply Fees: varies by class

B. Admissions Procedures

All families must be registered members before they can sign up for any classes.

New members:

- 1. Go to the WCA website. Review all policy documents and the classes offered.
- 2. Fill out the online Registration Application.
- 3. Wait to be contacted to schedule your family interview.
- 4. Complete the family interview.
- 5. If your family is accepted, submit the \$200 registration fee.
- 6. Once your admissions process is complete you will be instructed on the procedure to book classes.

Returning members:

- 1. Go to the WCA website.
- 2. Fill out the online Registration Application.
- 3. Submit the \$165 registration fee.
- 4. Returning families may have their membership status assessed prior to booking classes for the upcoming school year. WCA retains the right to refuse membership to individuals who have violated its guidelines.

C. Minimum/Maximum Grade Exception Policy

In general, class grade requirements are strictly followed. We understand each child works on his or her own unique learning curve. However, if you need to request an exception to the stated minimum/maximum grade for a class, please do so *before* booking the class. This is to avoid foreseeable difficulties and to ensure fair enrollment for all WCA members.

IV. Instructor and Tuition Policies

WCA does not employ instructors. Instructors are under the employment of the families who have a student attending their classes. For this reason, we do not pay the instructors. You, the parents, pay the instructors directly. We are simply a community at which instructors and students can convene, providing assistance and encouragement to homeschooling families. Each semester will be a minimum of 12 contracted weeks. Semesters that are longer than 12 weeks allow for weather cancelations, illness, and anything that would prevent class from occurring. If they are not used, they require no additional fees from the parent. Each instructor determines the tuition for his/her classes. All tuition and supply fees are listed in the course descriptions.

Instructors reserve the right to remove, or deny a student, from their class. As the instructor is under the employment of each family, they have the ultimate decision on who they choose to allow in their class.

Tuition is a <u>semester obligation</u>. The WCA Board and administration trust that families fulfill their enrollment contract by participating in WCA for the entire year. All WCA classes are a full year duration with a drop/add period in November. During the drop/add period, you may drop a class or add any available class. If you do nothing, you will remain in the classes you are enrolled in.

Tuition may be paid in full before or on the first day of the Welcome Back Event or in 2 monthly installments to be paid according to the tuition schedule for the Fall Semester. Spring Semester tuition may be paid in full before or on the first day of class of the Spring Semester or in 2 monthly installments to be paid according to the tuition schedule for the Spring Semester. (See the course descriptions page on the website.)

Instructors have the right to turn away students with unpaid accounts. A cancellation fee of a minimum of \$50 is due for any class dropped after the drop/add period for the Fall or Spring semesters and before the first

week of classes. This fee will increase to a minimum of the first payment and/or the full semester tuition payment once classes begin for the semester. Each semester has a dedicated add/drop time as well as the penalties. This information will be posted in the Facebook group as well as emailed out each semester. Unpaid and late payment of tuition and fees can result in removal from WCA and/or disqualifying the family from returning in the future. Tuition and fees must be paid in order to participate in events, field trips, etc.

Tuition payment information will be provided by the instructor of the contracted class. Tuition payment and fees are paid directly to the instructor. **Tuition and Fees are non-**refundable!

V. <u>Safety Policies</u>

Please note that these are subject to change based on requirements from our host facility. All updates will be sent prior to the first day of class.

Leaving your children at any time with WCA and/or on the premises of the hosting church without supervision is at the sole risk of the family. Instructors will be responsible for registered students in their classes for the time periods that their classes cover. Of utmost importance for all of our children is safety in the church parking lot. Please drive with extreme caution in the parking lots, and do not allow your children to walk in the parking lots unattended. In addition, no one is allowed to play in the parking lot at any time. All parents, please carefully supervise your children!

Gap-Period: Students (ages 13 and up) are allowed only **one unsupervised gap-period** in their schedule which **may not occur prior to their first class, or after their last class.** (Exceptions may be approved by the directors.) A student may not have more than 2 total gap periods in one day without supervision. If the student has more than one gap-period between classes, the gap-period is prior to a student's first class, after a student's last class, or a student has more than 2 total gap periods in one day, a parent must be present and actively supervising their student. Students (ages 12 and under) are **NOT** allowed a gap period without direct supervision. No students are allowed to play out-of-doors unless a WCA representative or a parent is **actively supervising**. Allowed areas are- the back grass field. All other areas (including the front/sides of the church, patio, side hills, shed, etc) are out of bounds.

Pick up: Pick up your children promptly at the end of their class. We must not have unattended students waiting for their parents to arrive.

Classroom Hallway: No one is allowed to enter the hallway with the metal double doors leading to the classroom area except students heading directly to class, the monitors and instructors. No one else will be allowed in that area. Exception – preschool families walking their child to and from class. 2nd Exception – first week of classes to help students get oriented.

Lobby: There is to be no congregating in the lobby! This area becomes congested very quickly with pickup during each hour. Students are to go directly to their next class, the fellowship hall, or leave/join the dismissal line.

Car Line: **DO NOT pass another car in the car line!** If they are loading children in the car, please wait patiently. If you are in car line and your child is taking a while to get to the door, we will ask you to loop to the back of the line as to not hold up the line.

Teen Tags: Teens ages 13 and up can pick up a "teen tag" that will allow them to leave the building without parent pickup. As a reminder, no one is allowed to hang out in the parking lot unsupervised. Students who are in the parking lot unsupervised will lose their "teen tag" and will be required to have a parent pick them up.

Parents/Adults: Please limit the use of the building to waiting in the fellowship hall while students are in class, or if you are coming in to use the restroom. If you are coming only for drop off/pick up; we are asking you to please remain outside.

Parents will not be allowed to enter the building during class change time to retrieve students. Students will be dismissed via the car line/walk-up pick-up process only. If you are bringing a student to class and are planning to wait in the fellowship hall you may enter the building, but will not be allowed down the classroom hallway. If you are arriving to pick up a student outside of the class change time, :20-30 of each hour, you will need to park and walk up to the building.

If you are sitting in the parking lot in your car, or outside with other children, you are welcome to join the walk-up line with your car tag for quick pick up. * Please note that those in the car line will receive first priority to keep the line moving. *

VI. <u>Conduct Policies</u>

WCA does not function as a school with a principal, support staff, custodial, and maintenance crew. Each member must cooperate to keep our facility clean, quiet, and orderly. It is very important that all WCA members realize we represent home education, and that we should demonstrate exemplary behavior for our peers, our instructors, our administration, and for the church we have been graciously allowed to use.

The following rules of conduct are required from WCA students as we strive to be an exemplary organization. Parents are responsible for their own children's behavior and must ensure that they are acting in accordance with these rules. These rules apply not only during WCA Tuesday and Thursday class offerings, but also at those times and places that WCA members are participating in, or supporting WCA sponsored activities.

To show thoughtfulness and respect for our host church:

- 1. Do not enter any portion of the church other than the designated WCA areas.
- 2. Eating is only allowed at the tables in the Fellowship Hall and in classrooms with instructor permission.
- 3. Any trash created in the classrooms, lobby, outdoors or bathrooms must be thrown away properly.
- 4. Bathrooms must be kept clean. Toilet malfunction should be reported promptly to the monitor(s).
- 5. Any spills or messes must be cleaned up promptly and not left for others to handle.
- 6. No running or loud active playing is allowed indoors.
- 7. No dangerous or damaging items are allowed at WCA (i.e. guns, baseballs, knives, water guns).
- 8. No skateboards, roller skates, bikes or heelys allowed in the building or the parking lot.
- 9. Do not vandalize; this includes no writing on tables, walls, mirrors, chairs, etc.
- 10. Church and WCA property is off limits. If it doesn't belong to you, don't touch it.
- 11. Do not contact the host church or staff for any reason! All communication, concerns, requests, etc MUST go to the WCA Administration.

To show thoughtfulness and respect for our instructors:

Students:

- 1. Arrive to class on time; if you arrive late please enter the classroom quietly and do not disrupt the class in session.
- 2. Wait for the instructor to dismiss the class, gather your things promptly, and go directly to your next class in an orderly manner.
- 3. There is to be no hanging out between classes. Again, go directly to your next class.
- 4. Complete your assignments on time, and remember to bring them to class.
- 5. Raise your hand rather than interrupting.
- 6. Listen attentively in class. **Do not socialize in class** with classmates while the instructor is teaching.

- 7. Conversations in the Study Hall should be kept quiet so that they are not heard outside of your immediate area and to not disturb classes or other people in the room.
- 8. Cell phones, electronic games, airpods/earbuds, and personal music are not allowed in the classroom. If used in class without permission, these items may be confiscated and held until the end of the student's day where a parent may claim it from the hall monitor.

Parents:

- 1. Respect the authority of instructors, administration, and representatives (including monitors) of WCA.
- 2. Make tuition payments on time and be sure that you pay the correct amount. Late fees may incur for payments not made on time.
- 3. Keep your phone on and respond to it while your children attend classes so that the monitors may reach you if necessary.

To show thoughtfulness and respect for all participating families:

- 1. Conduct yourself in a way that your words and actions promote unity & encouragement.
- 2. Avoid foul language, disrespectful, offensive, and rude behavior.
- 3. Avoid gossiping about one another. Handle conflict privately and with maturity.
- 4. Avoid horseplay and rough housing.

To show thoughtfulness and respect for WCA leadership:

- 1. Bring input and opinions to the WCA Administration in a responsible and respectful manner.
- 2. Handle conflicts with maturity by avoiding gossip and taking it to the WCA Administration.
- 3. Recognize the leadership as voluntary and afford them a good measure of grace and gratitude.
- 4. Respect the boundaries set forth by the instructors and WCA Administration including designated breaks and communication methods.

Gap-Periods: Students ages 13 and up may have only **one** "gap-period" **between** classes and no more than **two** "gap-periods" total in one day. A "gap-period" is defined to be a class period during which the student is not enrolled in a class. During a gap-period, the student must stay in the study hall area quietly. The availability of the study hall area is a **privilege** and can be taken away. Students who drive themselves may leave the premises during their break with the permission of their parent(s). This gap-period cannot be prior to and/or after the student's first/last class. If a student has more than one gap-period between classes, then a parent must supervise them during their break. Students **must leave** at the end of their last class via parent pick up or driving themselves.

Fellowship Hall Policies: The Fellowship Hall is a privilege for students and parents that we are fortunate to currently have. This space is for the students to wait quietly between classes, if allowed, according to the gap period policy. This space is also for parents to wait for their student while in class and/or with other children. The priority of the Fellowship Hall is the class in the classroom area. The noise level MUST be considerate of the class in session. Anyone, students and/or parents, may lose the privilege to wait in this area if these policies are not followed.

The Fellowship Hall is not a place to congregate. Students should only be in the Fellowship Hall if going to/from the classroom in there, waiting during their gap period, or have a specific reason to be there. (Example – restroom, snack bar, ticket sales, etc.)

There is no available internet that can be used while in the building, including in the Fellowship Hall. The use of hotspots and cell service may occasionally work, but it should not be relied on.

Bathroom Policy: There is to be no playing or hanging out in the bathrooms. This is not a place for students to gather. Please ensure that the faucets are turned off and trash thrown away before leaving the bathroom. Do NOT flush or put anything in the toilet except toilet paper. This includes feminine products, paper towels, etc. Do NOT try to flush too much toilet paper. Please be considerate of our facility and its septic system.

Individuals are expected to use the restrooms that align with his or her biological sex at birth, with the exception of young children or disabled individuals who require the assistance of an adult or family member.

Bullying Policy: Bullying, including cyberbullying, is not permitted by any student, parent, instructor, or administrator while attending WCA. This includes while on campus, at WCA events and activities, and when communicating with WCA administration, directors, instructors, families and students. Examples of bullying include but are not limited to the following:

- Verbal bullying is saying or writing mean things. Verbal bullying includes but is not limited to:
 - Teasing
 - Name-calling
 - Inappropriate sexual comments
 - Taunting
 - Threatening to cause harm
- Social bullying, sometimes referred to as relational bullying, involves **hurting someone's reputation** or relationships. Social bullying includes but is not limited to:
 - Leaving someone out on purpose
 - o Telling other children not to be friends with someone
 - Spreading rumors about someone
 - Embarrassing someone in public
- Physical bullying involves hurting a person's body or possessions. Physical bullying includes but is not limited to:
 - Hitting/kicking/pinching/tripping/pushing
 - Spitting
 - Taking or breaking someone's things
 - Making mean or rude hand gestures

Dress Code: Students and parents should dress appropriately so as not to be a distraction. Clothing with inappropriate/obscene pictures or slogans is not allowed. Shirts should cover the midriff and not be low cut; no crop tops allowed. Shorts/Skirts should be long enough that the butt is not seen. Bottoms should be worn properly and not hang below the butt, no low riders. In case of violation, parents will be called to bring suitable clothing for the child who will not be allowed in class until appropriate attire can be worn.

Drug and Alcohol Policy: Alcohol, drugs and drug paraphernalia, vaping and vape paraphernalia, tobacco, and cigarettes are NOT allowed on WCA property or at WCA student events or activities. In addition, students and parents are NOT allowed on WCA property or at WCA student events or activities while under the influence of alcohol or drugs.

Public Displays of Affection Policy: Public displays of affection are prohibited. Students are not to touch each other while on campus or at WCA events or activities. Examples of PDA include but are not limited to: hugging, kissing, holding hands, sitting on another student's lap, putting legs across another student's lap, etc.

Weapons and Firearms: Weapons are not allowed at WCA or WCA events. Weapons consist of: knives, swords, etc. This includes, but is not limited to: replicas, 3D printed versions, toys, etc. (Exceptions may be allowed at specified times and ONLY with the approval of WCA leadership. Example – Nerf battle event, a replica sword for history class, etc.).

Firearms are <u>STRICTLY</u> prohibited at WCA and WCA events. At no time will a student, parent, administrator, volunteer, etc be allowed to bring a gun to WCA or WCA events. This includes toy and/or 3D printed guns made to look like a real gun.

Conduct Policy Consequences

- 1. 1st offense **Email** to parent(s) from administration.
- 2. 2nd offense Meeting with parent(s) and student(s) with administration.
- 3. 3rd offense Removal for the remainder of the semester.
- 4. 4th offense Expulsion

Consequences may not follow this progression and may vary depending on the offense.

Participation in WCA and its associated activities is a privilege. The WCA leadership, if faced with conduct violations by a participant, or their family, can terminate the participant's and/or family's enrollment immediately.

We require exemplary behavior and student accountability. If an adult corrects a student, the student is to respond respectfully and return to appropriate behavior. If a student responds disrespectfully and/or does not return to appropriate behavior the student may be removed from the class or activity and will be supervised by a monitor until the end of that class/activity.

As previously stated, dismissal from WCA does not release a family from the obligation of tuition and fees.

VII. General Policies

Illness Policy: In an effort to keep everyone healthy do NOT send anyone to WCA if there is illness in the house, or if there has been illness in the house in the previous 24 hours. This includes colds, flu, strep, covid, lice, diarrhea, etc. Students will be sent home if they are exhibiting any signs of illness or if there is illness in the home.

Digital Media/Photo Policy: Any photo or media image taken by WCA-authorized members may be used for promotional purposes. By registering with WCA, all parents agree that images that may include their children may be taken for, as well as used for, the yearbook.

Inclement Weather: In the event of inclement weather WCA Administration will determine whether to close, or delay opening WCA. Information will be emailed and posted in the WCA Facebook group. In all cases, please use your best judgment before venturing out in bad weather.

Grades: For students who have completed WCA high school classes, instructors may provide final grades via the current Learning Management System and/or by email.

Special Needs: WCA is not equipped to accommodate all student needs. If your child requires special considerations, they must be communicated to the instructor and administration before scheduling classes. The instructor reserves the right to determine if your child is a suitable fit for the class. Special accommodations may or may not be granted based on evaluation of the specific situation.

Drivers: When a student enrolls at Williamsburg Classical Academy, and the student drives him/herself to and/or from WCA and/or WCA events, he/she and their family members agree to our Driver Policy as defined herein. All drivers (student, parents, instructors, and visitors) are required to comply with all driving laws, and WCA and their Hosting Church driving and parking regulations: obey a 5 MPH speed limit on campus, obey all

stop and directional signs, yield to pedestrians, drive in a reasonable and safe manner and refrain from using a cellular device while driving. Failure to abide by these rules may result in suspension of your driving and parking privilege.

All drivers and vehicles must be properly registered and insured in accordance with state laws. All drivers must have a valid, issued driver's license. Neither WCA nor their hosting church shall assume any responsibility for damage or theft to vehicles or other items of personal property left in the vehicle. Students are reminded to ensure that their vehicles are locked at all times while parked.

Classroom hallway: Only instructors, students in class and monitors are allowed through the double doors to the classroom hallway. Preschool parents are the exception and may walk their children to and from class.

Animals: Pets brought to WCA must be kept on a leash and in your control at all times. They are only allowed in the back grassy field - they should not be brought near the building or overhang. Animals must be cleaned up after.

VIII. Honor Code

1. Academic Dishonesty

Any form of academic dishonesty is a serious offense in an academic community. At WCA such dishonesty can result in removal from the class, a grade of zero on the assignment and/or the class, removal from the WCA community, or some combination of these as determined by each instructor. Academic dishonesty includes but is not limited to:

- 1. Plagiarism: Failure to acknowledge ideas, phrases, data, music, or images used in any paper, examination, quiz, report, presentation, exercise or project submitted in a course but gained from another person.
- 2. Misrepresentation or falsification of data in any coursework.
- 3. Self-plagiarism: the submission of one piece of work in more than one course without the written permission of the instructors involved.
- 4. Cooperative or collaborative effort in coursework without the explicit permission of the instructor. Assume collaboration and/or cooperation are not permitted unless you are expressly informed that they are. This is not meant to inhibit discussion and debate of academic subjects either inside or outside the classroom.
- 5. Cheating on examinations or tests: to give or receive assistance from written material, another person, his or her paper, or any other source, including electronic sources, or to attempt to do so, during an examination or test. The only exceptions will be at the explicit instruction of the instructor of the class.
- 6. The submission of work as one's own that has been prepared by another person.
- 7. Stealing, altering, redirecting, or otherwise tampering with the form or content of digital media created or presented by another person without explicit permission of that person.

2. Student Obligation

Aside from refraining from all forms of academic dishonesty, WCA students are expected to take proactive steps to support the Honor Code and to respond to incidents of academic dishonesty. Such steps may include:

- signing a pledge on as assignment or test stating that the assignment has been completed in accordance with the Honor Code;
- reporting suspected dishonesty to the instructor;

Violating an instructor's honor code is a serious offense and may result in dismissal from the class.

IX. Medical Treatment Authorization

Any Instructor or Volunteer at Williamsburg Classical Academy can give minor medical care (including, but not limited to, washing and putting band-aids on, using ice packs for bumps, etc.) as needed while students are at WCA. This is at the instructor's or volunteer's sole discretion. The Instructor or Volunteer at WCA can obtain immediate care in the case of a medical emergency as determined solely by them, in the event that the parent cannot be consulted or located, or if the care is believed to be so urgent that there is no time for consultation with the parents/guardians. Parents will be solely responsible for any expenses, which may be incurred in providing treatment to their child.

If needed, parents will provide an **Emergency Action Plan** for Allergies and/or other Pre-existing Medical Conditions (a step-by-step plan of what someone should do in a medical emergency caused by an allergic reaction or pre-existing medical condition). This plan is for WCA's information only; it doesn't create an obligation to follow it, although efforts may be made to follow it. Williamsburg Classical Academy assumes no responsibility for any treatment or actions in response to medical incidents, medical emergencies or medical conditions. Parents are responsible for promptly providing a detailed emergency action plan if one is needed, as well as talking to their child(ren)'s instructors regarding allergies/medical conditions before their child begins classes. (Parents are to consult their doctor for information about how to make an Emergency Action Plan for their child.)

X. Releases of Liability

When a student enrolls at Williamsburg Classical Academy, they and all family members agree to the following releases of liability:

In consideration of being permitted to participate in Williamsburg Classical Academy in any way, all participants, students and all their family members and guardians [hereinafter referred to as "Family"] agree to the following:

Release:

1. Release, covenant not to sue, waive, and discharge Williamsburg Classical Academy, their independent instructors, advisors, administrators, board members, volunteers, participants or other family members, or the hosting church, their officers, employees, board members, administrators, instructors, volunteers, participants or other families participating in Williamsburg Classical Academy or hosting church (hereinafter referred to as "Releasees") from all liability for any loss or damage and any claim or damage on account of injury to the person or property or resulting in death of a Family member while Family is participating in Williamsburg Classical Academy activities.

Assumption of Risk:

- 2. Family agrees to indemnify Releasees from any loss, liability, damage or cost Family may incur due to the presence of Family in or on the premises of the hosting church. Family realizes transportation to and from Williamsburg Classical Academy or any time off campus is the Family responsibility. Family also realizes that times between classes, gaps in schedules, before and after classes, and days and hours that instructors are absent are the Family responsibility. Leaving your children at any time with Williamsburg Classical Academy and/or on the premises of the hosting church without supervision is at the sole risk of the Family.
- 3. Family assumes full responsibility for and risk of bodily injury, death or property damage while in or on the premises of WCA's hosting church and/or while working for any purpose participating in WCA activities.
- 4. Family expressly agrees that this release waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Virginia and that, if any portion of the

- agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
- 5. Family, in consideration of being permitted to participate in Williamsburg Classical Academy, for Family, and Family's heirs, executors, administrators, and assigns, releases and forever discharges all Releasees, and their heirs, administrators, and executors of and from any and every claim, demand, action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death or property damage participation in Williamsburg Classical Academy or any activities in connection with Williamsburg Classical Academy or on the host church's property.
- 7. Family releases all hosting church and WCA officials, administration, instructors, volunteers and all others listed as "Releasees" above from any claim whatsoever on account of first aid, treatment or service rendered to the Family during participation in Williamsburg Classical Academy. I understand that I will be solely responsible for and will pay any expenses which may be incurred in providing treatment to the Family.
- 8. Family acknowledge and fully understands that each member/participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions, or negligence but the action, inaction, and negligence of others, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
- 9. Family assumes all the foregoing risks and accepts personal responsibility for the damages following such injury, permanent disability or death.
- 10. Family releases, waives, discharges and covenants not to sue WCA, its affiliated clubs, their respective administrators, directors, agents, other members/participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, all of which are hereinafter referred to as "releasees," from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death and damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise.

The family also acknowledges:

- 11. That the Mother and/or Father of Family have carefully read the above release and know and understand the contents of the release and their significance and sign this release as Family's own free act.
- 12. This agreement shall be binding on each member of the Family, their personal representatives, assigns, heirs, and next of kin.
- 13. This release contains the entire agreement between the parties to this agreement and the terms of this release are contractual and not a mere recital.

XI. Enrollment Contract

When parents enroll their home-schooled child(ren) in a supplemental class, or classes, activities, events, etc, for the school year at Williamsburg Classical Academy, they are agreeing that they:

- understand that WCA's commitment is for the school year, as decisions to offer classes are based upon enrollment, and WCA must plan for classroom space and organizational expenses.
- have read, understand and will abide by the *Williamsburg Classical Academy Inc.* **Parent and Student Handbook.**
- have read and understand the *Williamsburg Classical Academy* **Tuition Policies as stated in the Parent and Student Handbook.** Parents agree to pay all tuition in accordance with these policies, and acknowledge that if they withdraw their children or they are dismissed from WCA, they are still responsible for the semesters' tuition they contracted for as explained in the policies.
